David Harrison noted that we are very lucky to have our investments to fall back on General account okay as far as investments concerned was actually up \$3,700 as per Gerry Mercer Cemetery fund - the investment is sitting at \$51K - devalued about \$5K due to market conditions - Cemetery fund 4.43% increased in value by \$20K over last 2 years. No pending expenses and have sufficient expenses to get through.

Joyce Eaton requested an update on furnace mortgage – payments in 2022 and how many years are left – request will be provided to Ron Dunn Treasurer who will provide an update as soon as possible. It was noted that ACW financials are now part of main general fund.

Detailed 2022 financial reports are in the AGM package.

2023 budget presented for review within AGM package as well. Stacey Ferguson commented on the budget on Ron Dunn's behalf reading his notes into the meeting record:

Gerry Mercer made a motion to adopt all the reports. Loretta Armsworthy seconded. Motion carried.

New Business – David Harrison expressed a thank you to Rev Lee & Rev Gary Sinclair for taking on the task of being our Priest-in-chare; Rev Lee is the official Priest -in-charge. Rev Lee Sinclair is meeting with the ACPC Council and Wardens to organize the specifics of their commitments. And they are here to help during this transition. Joint service every month to lessen the work on LLMs and Priest-in-charge. Will help with commitments of time for everyone but will also help with the building of connections with the other parishes. Attendees agreed this is a good idea to bring everyone together. We need to be willing to go outside our own area. Good idea just not at night.

Loretta Armsworthy asked if we are paying the bills at the Rectory (utilities, etc.) till June but we are not paying salary. Response was that the Rectory expenses are ACPC responsibility and will be paid but salary will be part of the Diocesan commitment not ACPC. The kindness has been extended to Rev Darlene Jewers to live in the Rectory for time to find another place to live. Attendees said it is the Christian thing to do.

Nothing else was brought forward.

- Synod delegate nominated (elected at ACPC AGM) Loretta Armsworthy and Gladys Morgan (nominated by Julie Wynands, seconded by Jason Ferguson) – from the floor - Motion carried

Priest in Charge's Report 2023

An Annual General Meeting is a time of looking back at the year that is past, and forward to the year to come. We evaluate where we have been and what we have accomplished, then plan where we want to go and how we want to get there.

Looking back at 2023, there were no weddings at ACPC; there were 5 baptisms (2 at St. Bees and 3 at Christ Church); and 14 funerals and/or interments (St. Bees at 6, Christ Church at 3, and St. James at 5). There were several home communions to shut-ins.

As far as we know, Jesus never attended an AGM. He never left us a template for nominating leadership, creating a budget, or passing resolutions. Perhaps He trusted that we would be able to figure it out, after prayer and discussion.

In moving forward, then, we have to look to scripture for guidance. There are many passages that we can turn to for direction, but one of my favourites is found in Matthew's gospel, chapter 13 verses 3 to 8. It is the parable of the Sower and the Seed. It starts this way: "A sower went out to sow". Many scholars interpret the sower in the parable as being God, who sows the Word, Jesus, in the hearts of people. Sometimes the Word is sown in fertile hearts, sometimes not. Sometimes good comes of it, sometimes not.

As Christians we are all called to follow in the footsteps of Jesus to become more God-like – more loving, caring, peaceful, merciful, justice-oriented, and compassionate (just to name a few).

Therefore, we are called to sow the Word, Jesus, in the hearts of others: we sowers went out to sow. But we can also expand on the words of the parable. For example, if you are someone who likes to pray, what would it mean to you to contemplate this: "A pray-er went out to pray"? Or if you are a helper, "A helper went out to help". An organizer went out to organize. A teacher went out to teach. A healer went out to heal. A Christian went out to love.

Notice the two words in the middle of the phrase: "went out". We are all called to take our skills, talents, and abilities out from our church buildings into the community. We do this individually and corporately. How will we do this in 2024? What are our goals and our plans to achieve those goals, both individually and corporately as a parish? How will we, as sowers, go out to sow, and what is it we will be sowing?

Warden's Report 2023

We have been blessed to have the Revs Sinclair here for the past year with the Rev Lee as our priest in charge. Will very definitely miss them when they retire at the end of June.

Our average attendance seems to hover around 17 for Sunday worship, however we usually have one or two join us for the live stream of the service and 10 to 20 or more people for the recordings of the service each week.

Many thanks to Carol and Ron Dunn for leading the renovations of the rectory. Also a huge thanks to the volunteers for all their hard work in bringing the rectory back to a habitable condition.

Many thanks to the LLM's for all the hard work that they do on our behalf. Without them, we would struggle to have regular worship!

We, both as a congregation and individually have participated in many mission and outreach projects over the past year: foodbank; Roots for Youth; supplies for elementary students; mitts for students; snacks for the 5th floor and palliative care; pillowcases for palliative care, quilts for Tearmann House and Roots for Youth, prayer shawls and other projects which I have probably forgotten! We also host Sparks and Guides in our hall every week at no charge to them. As you can see, while we may be relatively small, we are active!

Technology

As previously mentioned, we live stream and record our services. A word about the process: Dave puts the service on to PowerPoint, then sends it to Julie so she can insert the hymns and puts together the "script" for the use of everyone in the chancel; she then sends everything back to Dave so he can run off copies of the Script and load the PowerPoint on a computer in the church.

In July Dave purchased a special camera that moves and Zooms remotely (it is called a PTZcamera- "point, turn, zoom) for use in the church, this has made the video of the service easier to do, however the software that is used for recording and streaming is somewhat "glitchy" which occasionally causes problems, it is free software and you sometimes get what you pay for!

The computer that is used for showing the service to the congregation will need to be upgraded at some point as Microsoft is planning on stopping support for Windows 10 fairly soon. Dave is not suggesting purchasing a new computer, rather, he will change the operating system to Linux (which is free) and use a free replacement for Microsoft Office called Libra Office, which is using currently.

The laptop, camera and networking equipment that is used to live-stream and record the service is owned by Dave.

There haven't been any property projects over the past year, as nothing has come up, and steeple repairs are pending. Once we get the logistics to align in our favor, work on the steeple can commence.

The town of Stellarton was over to install a water meter, and we were unable to locate the water main at the time, and the town decided to forego the installation of a water meter at this time.

The property committee does plan to do the work to attempt to find the main, as we currently don't have any way to turn off the water to the basement and we would like to change that.

Some minor work will be required on the vestry steps, as part of the railing was impacted by the weight of the snow falling off the roof, and some other minor repairs as needed around the property.

Thanks to ACPC for paying for the cleaning of the rectory, and a joint effort by all ACPC Members to get the rectory to get it cleaned up and some renovation work done to make it a more livable space. Thanks to Ron and Carol Dunn for leading the charge on this, as a lot has been accomplished with only a couple tasks left yet to conquer.

We continue to have the snow cleared, using a private contractor for which we are very grateful.

The repairs and refurbishments began with having the main floor professionally cleaned by Paul Davis, due to rodent droppings in the house.

From then, small groups worked nearly every weekend until Christmas, and then began working again in January.

Work that has been done:

- Repaired damaged plaster.

- Repainted ceilings, walls and trim in all rooms.
- Installed new flooring in laundry room.
- Removed carpet from main stairs and refinished the stairs. When this report was written, applying new stain was not completed.

- Replaced all light bulbs.
- Cleaning of the entire rectory has begun, but was not completed when this report was written.
